BOOK PROJECT

I am currently working on a book. Its working title is *Individuation: The Arts, Free Speech, and Experiments in Living*. This work will examine the position of the arts in free speech. I will argue that we need to appeal to a relatively neglected ideal from the liberal tradition – namely, the ideal of ‘experiments in living’ – in order to account for the central position that the arts have occupied in the law and politics of free speech.
